TERMS & CONDITIONS OF ENTRY 'Doyles Croser Club Prize' PROMOTION

1) These Conditions relate to the "Doyles Croser Club" competition. Information on how to enter and prizes form part of the terms and conditions of entry. 'The Promoter' is Doyles Seafoods Pty Ltd . ABN 20 000 285 763.

2) The competition commences on Thursday 8 February 2007 at 00:01 AEST and closes on Thursday 31 January 2008 at 23:59 AEST (the 'promotion period').

3) One prize available, drawn each month a total of 12 individual prizes:

The monthly prize will be drawn on the 4th of each month starting March 2007 and continuing until April 2008

4) Participants enter the competition by completing an entry form at a participating restaurant

5) Eligible participants must complete their name, postcode, telephone number, birthdate and email to be eligible to win.

6) Entrants may submit as many cards as they wish. One card is permitted each time a diner eats at a participating restaurant. The Promoter's decision is final and no further correspondence will be entered into.

7) Entry is open to all residents of Australia. Employees and their immediate families of Restaurant Marketing, sponsors supplying prizes and the participating restaurants, are not eligible to enter.

8) Details pertaining to the prize pool are as follows. The winners as determined by the Promoter under criteria stated above will be offered 1 nights accommodation including breakfast for 2 at Doyles Palace Hotel. The package is valued \$150.
